A. Purchaser agrees the above-described puppy/dog is in sound, good health and free from all communicable diseases, as far as it appears from inspection by Purchaser at the time of sale. Purchaser accepts the puppy/dog "as is" at the time of sale. Purchaser has the right to have the puppy/dog replaced by us subject to **ALL** of the following conditions:

1. Purchaser shall have the puppy/dog examined by a licensed veterinarian within 72 hours from the time of sale. If such examination reveals any life threatening health disorder that could cause the death of the puppy/dog, we will replace the puppy/dog, provided the findings and results of such examination are in writing and sworn to by the veterinarian and the veterinarian's report is delivered to us within 24 hours of the examination. Ear mites, worms and Coccidia are not serious health problems if treated and are not covered as reasons for any replacement.
2. There has been no neglect or abuse of the puppy/dog by the Purchaser that causes or aggravates any life threatening illness or disorder resulting in the death of the puppy/dog;
3. We shall have the right to have the puppy/dog examined by a licensed veterinarian at our expense, as soon as practicable upon receipt of the report from Purchaser's veterinarian, prior to making any replacement or adjustment. If we elect to have the puppy/dog examined by our veterinarian, and the findings and results of our veterinarian's examination agree substantially with those made by the Purchaser's veterinarian, we will replace the puppy/dog at no extra charge; and
4. **ANY REPLACEMENT SHALL BE OUR CHOICE FROM STOCK ON HAND OR FROM EXPECTED LITTERS AND WILL BE OF THE SAME QUALITY/SEX/COLOR (WHEN POSSIBLE) AND REGISTRATION. THERE SHALL BE NO REFUND OF THE PURCHASE PRICE UNLESS NO REPLACEMENT FROM STOCK IS AVAILABLE OR EXPECTED TO BECOME AVAILABLE.**

B. Subject to the foregoing, we will not be responsible for any expenses of a veterinarian or for any health care for the puppy/dog, or for grooming expenses or food, landlord's disapproval, allergies to people, or disagreements among household members of the Purchaser, after Purchaser takes possession and ownership of the puppy/dog.

C. Because of the danger of exposure to outside diseases, we reserve the right to refuse the return of any puppy/dog, in order to protect the health of the entire kennel.

D. A record of shots and worming is provided to Purchase of each puppy/dog. Each puppy/dog should not be socialized until the full series of shots is completed. We will provide Purchaser with a sample of dog food for the puppy/dog. Purchaser understands that any abrupt change of diet may cause diarrhea. We recommend that the puppy/dog be kept on the same diet as the sample.

E. We do not guarantee the adult size or color of each puppy/dog sold, or that it can be shown or bred.

F. IF FOR ANY REASON THE PUPPY/ DOG CANNOT BE KEPT, THE BREEDER HAS THE RIGHT TO HAVE THE DOG BACK WITHOUT A REFUND TO THE OWNER. BY SIGNING THIS AGREEMENT YOU ARE AGREEING NOT TO TURN THE DOG OVER TO A RESCUE GROUP, ANIMAL SHELTER, PET STORE ETC. IF THE PUPPY/DOG IS FOUND TO BE TURNED OVER TO ONE OF THESE PLACES, YOU WILL BE SUBJECT TO A FINE OF \$2500 AND MUST PAY ALL COURT COSTS.
